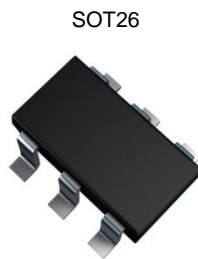

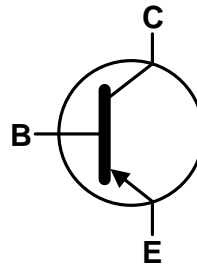

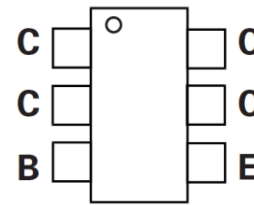

Device Symbol

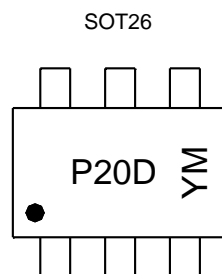


Pin-Out Top

Package Outline

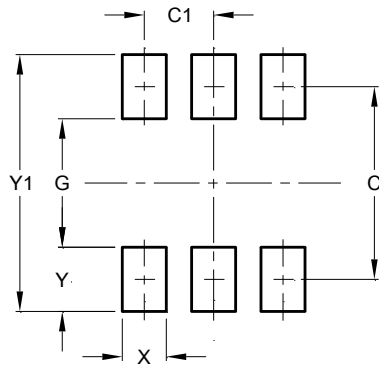
