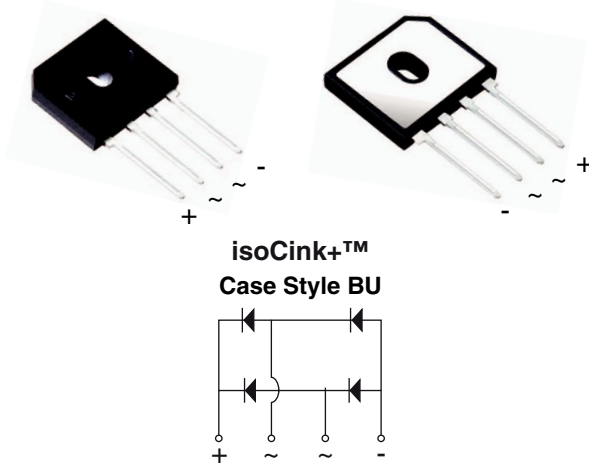

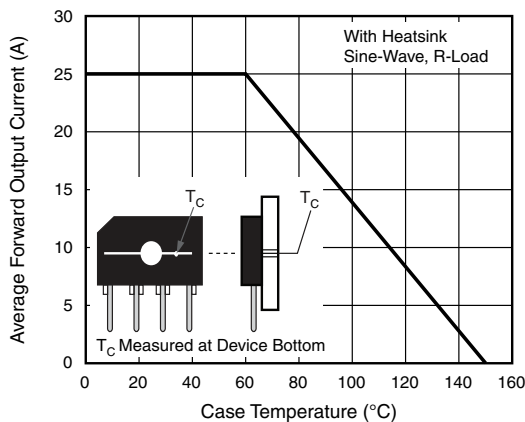
**RATINGS AND CHARACTERISTICS CURVES** ( $T_A = 25\text{ }^\circ\text{C}$  unless otherwise specified)


Fig. 1 - Derating Curve Output Rectified Current

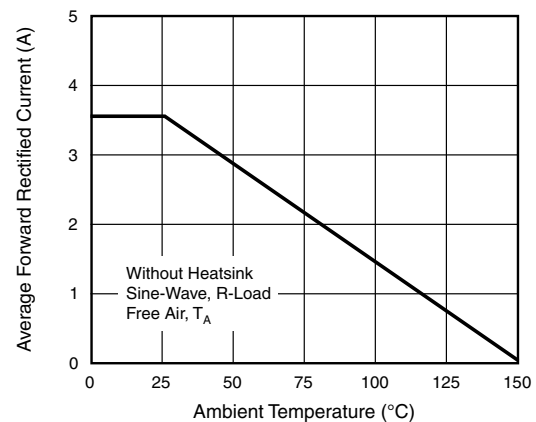


Fig. 2 - Forward Current Derating Curve

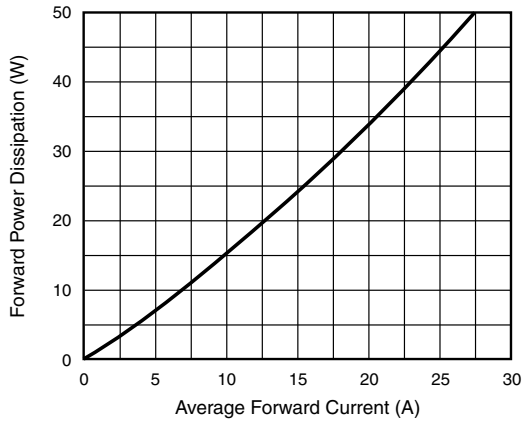


Fig. 3 - Forward Power Dissipation

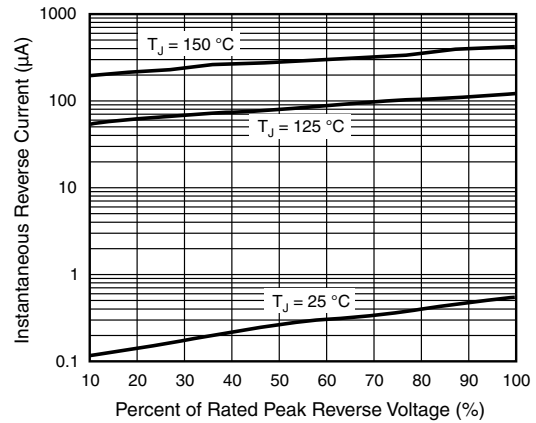


Fig. 5 - Typical Reverse Characteristics Per Diode

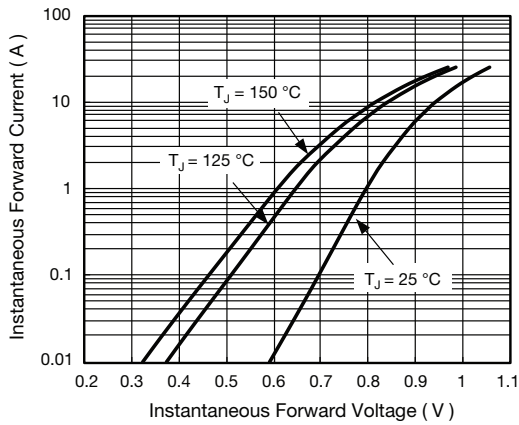


Fig. 4 - Typical Forward Characteristics Per Diode

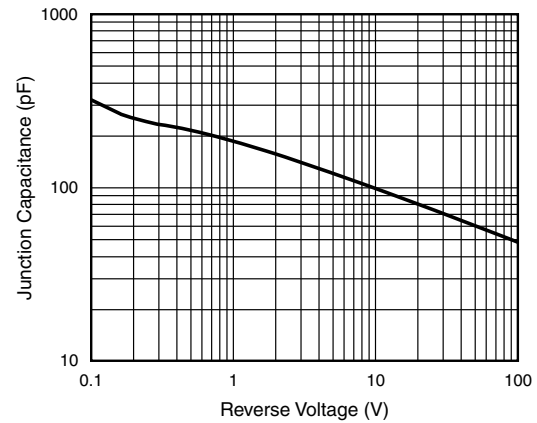
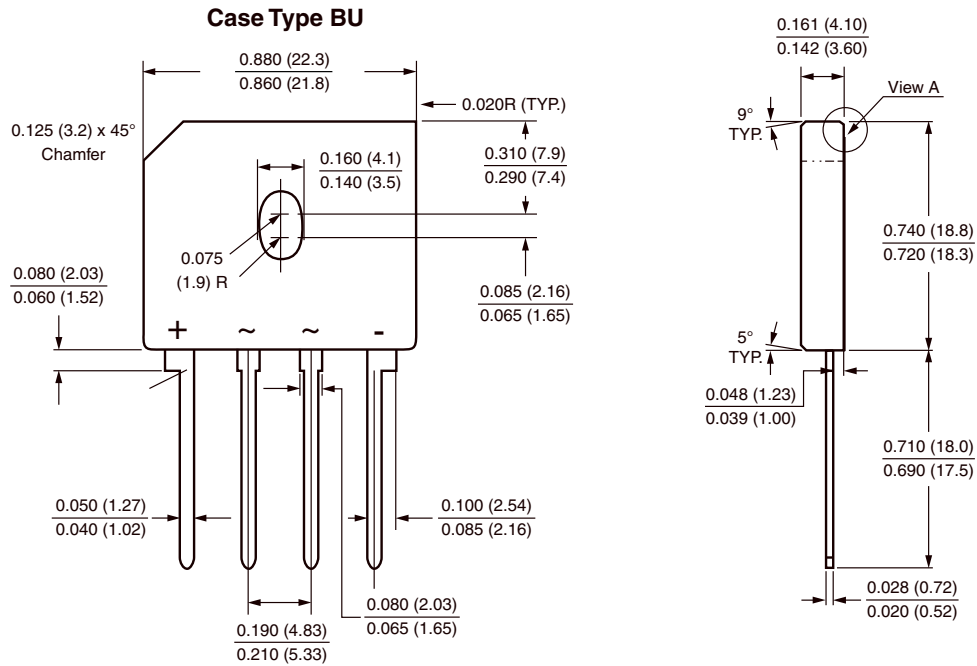


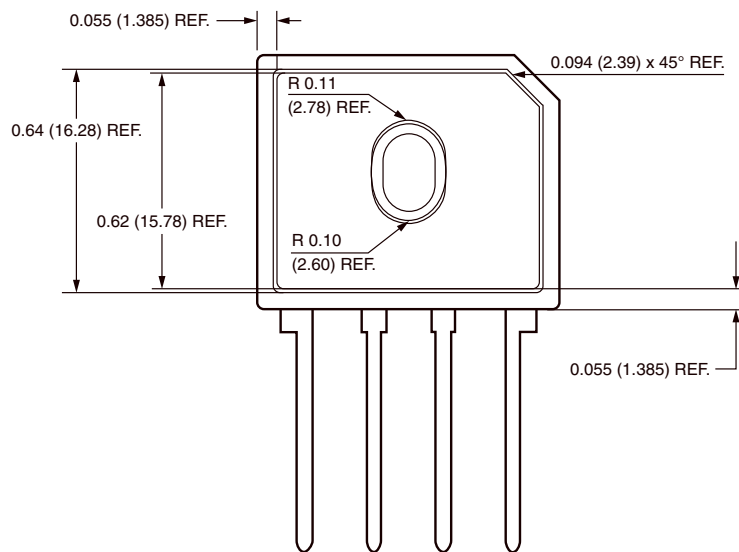
Fig. 6 - Typical Junction Capacitance Per Diode



PACKAGE OUTLINE DIMENSIONS in inches (millimeters)

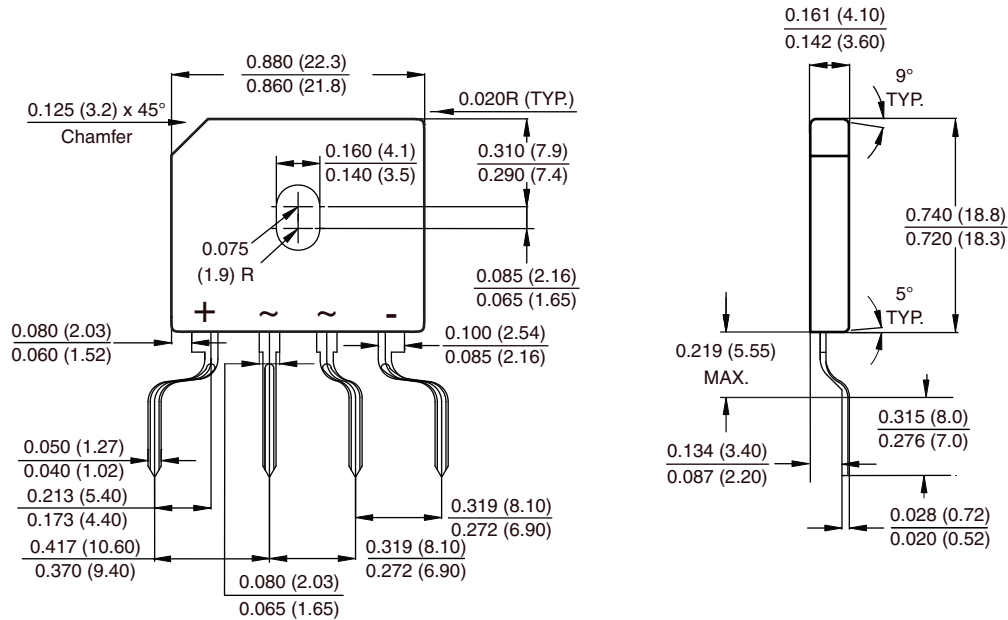


Polarity shown on front side of case, positive lead beveled corner



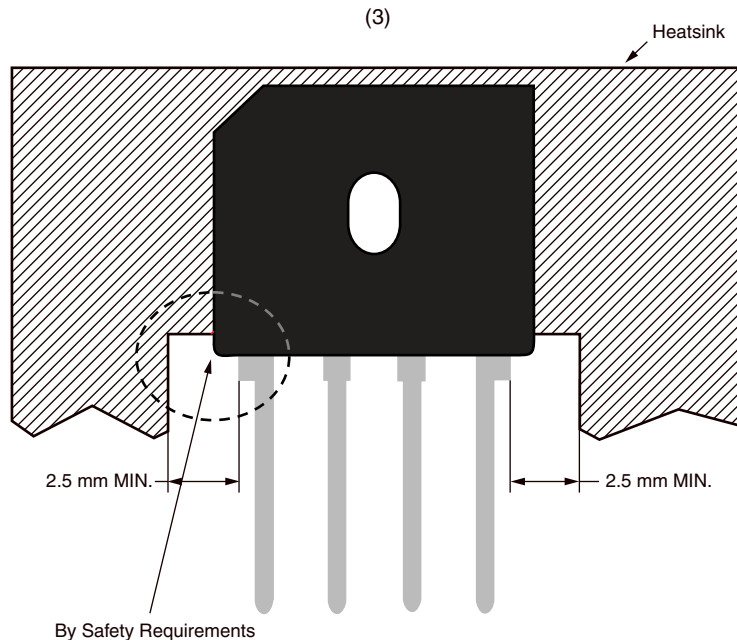


FORMING SPECIFICATION: BU-5S in inches (millimeters)
